



Terms and Conditions – Visiting and Participating at Nala Village

Entry to the park and participation in activities are subject to the following Terms and Conditions. By entering the premises, all guests agree to fully comply with these rules.

Nala Village reserves the right to update these Terms and Conditions at any time. Should any changes occur, visitors will be informed of updates through the website before their visit or participation.

1. Admission and Participation

Participation in Nala Village activities is permitted only after purchasing a valid ticket and completing prior registration. Events held at Nala Village are private and not open to the general public without advance registration and approval. All activities are undertaken at the visitor's own risk and responsibility.

2. Parking and Traffic

Parking is only permitted in designated areas on the property. Parking on public roads or blocking access routes is strictly prohibited. In the event of a conflict, local municipal regulations take precedence over these terms. Nala Village is not responsible for any fines, towing, or damages resulting from improper parking.

3. Use of the Grounds and Facilities

Lighting any kind of fire is strictly prohibited without express written permission from park management. Camping on the grounds is not allowed unless specifically authorized by park staff. Use of the lake and surrounding areas is entirely at your own risk.

4. Day Visitors and Food Policy

Guests participating in daytime activities who are not staying overnight in the park are not permitted to eat food on the premises unless given explicit permission by park management.

5. Liability and Personal Belongings

Nala Village and/or its representatives cannot be held responsible for any personal injury, damage, loss, or theft of personal belongings, unless such damage is the result of intentional misconduct or gross negligence by Nala Village or its management. Visitors are always responsible for their own personal property.

6. Compliance with Instructions

All visitors must follow the instructions of Nala Village staff and security personnel at all times. Nala Village reserves the right to deny entry, end participation, or remove any visitor who violates these Terms and Conditions, without refund.

7. Liability for Third-Party Activities

Participation in activities, workshops, or programs organized by third parties is entirely at your own risk. Nala Village accepts no responsibility for any injury, loss, or damage resulting from these activities, except in cases of deliberate intent or gross negligence by Nala Village or its management staff.

8. Personal Data

The organizer (Nala Village) will process visitors' personal data solely for ticket processing, event-related communications, and, if needed, accommodation arrangements. Data is processed based on the agreement between the visitor and the organizer and/or with the visitor's consent. Personal data will not be kept longer than necessary.
